## **Terms and Conditions**

### Obligation to Pay

Registration and participation in any NOC event constitutes liability for payment regardless of whether the participant is successful or unsuccessful in qualifying for certification.

### Participants

There is no limit on the number of participants covered under a single registrant. However, multiple registration forms may be required for large groups.

### Force Majeure

A reasonable attempt will be made by NOC staff to provide an opportunity for each candidate to successfully qualify for certification. Should an unforeseeable event beyond the control of NOC staff render certification testing impossible or impractical including, but not limited to, extreme weather conditions and other Acts of Nature, war or civil unrest, strikes, and equipment failure, compensatory arrangements will be made with the registrant. Participants should check the NOC web site at [www.yakimacleanair.org/services/nw-opacity.html](http://www.yakimacleanair.org/services/nw-opacity.html) the day prior to their certification testing to ensure there have been no scheduling changes.

### Certification Training

Online certification training materials are available at [www.yakimacleanair.org/services/nw-opacity.html](http://www.yakimacleanair.org/services/nw-opacity.html). Training is not required, but is strongly recommended for person not previously certified. Failure to adequately review the training materials before testing may hamper the ability of a participant to meet the requirements necessary for certification.

### Payment

Advance payment is not accepted. Following certification testing, registrants are invoiced for each participant in attendance. Payments by check and credit card are accepted. Make checks payable to: YRCAA and reference the invoice number on the check.

### Secondary Testing

Participants that fail to meet the requirements for certification during their event may attend any subsequent certification event during the same year and season (Spring or Fall) at no additional charge.

### Advance Registration

Registration in advance of certification testing is not required, but strongly encouraged so NOC staff can properly prepare for the number of participants. Unregistered participants for certification testing should arrive early to complete the necessary paperwork.

### Late Arrival / Cancellation

Participants unavoidably delayed or unable to attend the certification training for which they are registered should immediately notify the YRCAA office at 509-834-2050 ext. 100 so arrangements can be made.

### Certification Cards

Certification cards (wallet-size) are sent to each person receiving certification. Registrants not previously certified by NOC also receive a certificate (full-size).
